6 MINUTES OF THE KING GEORGE V PLAYING FIELD COMMITTEE MEETING held on 3rd December 2019

7 COMMITTEE BUDGET

8 YOUTH LIAISON

Members to note that Glenn Crickmore, Senior Youth Worker, Selvet Sanger and Laura Greene, Youth & Community Based Commissioners, Essex County Council will be attending the meeting to provide an update on their weekly visits to the playing field. Members to receive the detached session weekly reports from December 2018 to January 2019.

9 TEEN SHELTER

Members to discuss the proposed alteration (removal of side and back panels) or removal of the teen shelter following concerns regarding drug/solvent use in the area. Members to receive a quote from a company to remove the shelter and to remove the internal fencing and close the entrance to the car park with a response from ground contractor and Rayleigh Bar'N'Bus in relation to this issue.

Members to receive and consider information from a company who can provide support or assistance to prevent solvent abuse (attached). Additional information will be provided at the meeting.

Members to note that the Town Council called the Fire Service on the evening of the 10th December due to a fire in the teen shelter.

10 KING GEORGE V PLAYING FIELD - BOOKINGS

Members to note that all events that take place in the field incur VAT at the standard rate.

The Town Council Policy for field hire is:

Applications to hire part or all of the playing field will be considered at King George V Playing Field Committee meetings if a fully completed application form is received in time for inclusion on the agenda. Applications may be refused. The field or any part of it will not normally be hired out for any period exceeding one day, which is between the hours of 7.00am and 10.00pm. Applications for hire of more than one day will be referred to the Full Council for consideration. Fun Fairs that exceed one day may not take place in the playing field.

a) Moonbeamers

Members to consider a request from Moonbeamers to hold an outdoor cinema in the playing field on the evening of Friday 30th August 2019.

Moonbeamers have also enquired about an additional date on 24th May 2019. The event would finish at approximately 11.00pm and this could be a "Silent Cinema", if there are concerns with noise. The locking time of the playing field is 9.00pm during May and the ground contractor would need to be consulted.

A completed booking form has been requested for both dates.

b) The Mobile Bootcamp

Members consider a request from The Mobile Bootcamp to hire the playing field for 2-3 sessions a week with at least 1 session at the weekend if completed hire application form is received.

11 BOWLS CLUB

a) Chelsea Pensioners visit for 60th Anniversary – 19th June 2019

Further to minute no 110 of the King George V Playing Field Committee meeting held on 3rd December 2019 members to note that the Bowls Club may park a coach in the car park area, if size permits and hire the changing rooms on Wednesday 19th June 2019 from 1.00pm for the visit by the Chelsea Pensioners to celebrate the 60th Anniversary of the Club. The Town Council Chairman will attend this engagement. Additional details will be received in due course.

b) Field and Changing Room Hire 2019

a) Rayleigh FC Training

a) Shutter

The company will conduct a 6 monthly service at a cost of £120.

b) Internal Door
