Minutes of a meeting of the Town Council Held on **Monday 13<sup>th</sup> February 2023 at 7.30pm** at The Pavilion, King George V Playing Field, Bull Lane, Rayleigh,

## 20/23 Declaration of members' interests.

Cllrs Lumley and Newport declared interest as County and District Councillors. Cllrs D Belton, R Milne, C Roe, D Sperring, C Stanley, I Ward declared interests as District Councillors.

Cllr I Ward declared interest as a committee member of 1476 Squadron ATC. Cllrs Lumley and Sperring declared interest as Governors at Edward Frances Schools.

## 21/23 Public forum

There were eight members of the public present. Two of whom spoke on behalf of a recently felled tree in Ashingdon Parish expressing their frustration with the County Council's disregard for public opinion that wished to save it. Concern was also expressed about the dangerous nature of the road junction that is being built on the site. A particular plea was made on behalf of the fallen tree, objecting to the lack of engagement from the County Council when residents wished to challenge the decision. The speaker asked if ClIrs Scott and Shaw were going to resign.

## 22/23 To receive an update on highways matters from Cllr Lee Scott

In response to the comments from the public, Cllr Scott pointed out that decisions were collective and not made by individual councillors. Community Safety was the responsibility of his colleague Cllr Waglam. As for the specific concerns about local wishes to save the tree, the County Council can only operate within the law and there

was nothing they could do about a high court judgment and the developer's right to prosecute their business.

It was agreed that cuttings and acorns from the tree be propagated and added to the ECC tree planting programme.

All County Councillors are aware that they are being judged on the poor state of the roads and have allocated an addition £9 million for highways repairs; £4 million will be allocated to footway maintenance and £3 million to pothole repairs. These repairs may not be done as quickly as residents would like, and some will be makesafe repairs in advance of a proper job. It was acknowledged that the extra money will not solve all the problems, but it will help.

Cllr Scott confirmed that the streetlights will not be switched-off earlier, nor are they being dimmed.

To help the police manage speeding, they are being trained on the use of TruCam laser devices. These are improved hand-held speed cameras which will be rolled-out over the county and give the police additional power to address concerns about speeding.

In response to these comments, the Town Councillors raised concerns about potholes, considering some of them to be very dangerous and noting that it was deplorable that the roads have been allowed to deteriorate. This represents very bad value for money.

Moving to specific complaints. Grove Road is a particularly bad example of a bus route that needs extensive maintenance. The footways are in a poor state which make it difficult for the less mobile to access the buses.

It was reported that repairs to the footways in the high street occasionally used inappropriate material when paving slabs have been repaired by using tarmac. This is not just an aesthetic problem as the dark patches can been seen as holes by those with perception issues. The slabs themselves can cause problems as they become trip hazards.

Reminding the Town Council about the £4 million additional funding for footway repairs, it is expected that identifying necessary repairs will be Member-led as the local Councillor will have the best local knowledge. Reporting the problems will be through and online system which will be made as easy as possible> Cllr Newport confirmed that the system works but noted that not all County Councillors have taken advantage of the scheme.

An outstanding problem with the streetlights over the taxi rank will be addressed when Cllr Shaw meets representatives of UK Power Networks next week. The problems caused by the stumps of decommissioned lighting poles will also be raised. Moving to a more general question and answer session Cllr Scott was asked if his department could come-up with a system where adjacent potholes are repaired at the same time. He acknowledged that this could frustrate residents but pointed-out that the repair teams could only work to their job sheets, and there have been many occasions where residents have refused to move their vehicles restricting access to the area needing repair. Cllr Scott will be meeting with officers to consider how this can be managed.

In response to a question about the availability of high-speed pothole repair tools, ClIr Scott confirmed that they are not necessarily as good as claimed but they are being evaluated.

A request was made to have pedestrian crossing road markings repainted and the beacons refitted with halo lighting.

The speed table in Grove Road needs repair. Warwick Road, Clarence Road Chase Road and Grove Road are missing signage.

A request was made to have pedestrian refuges maintained, with their reflectors cleaned and lights repaired.

Keeping footways clear is another priority. Residents with visual impairment or physical mobility problems can experience problems with blocked or reduced pathways. Sometimes the problem is vegetation from private property but it can often be cars parked on the footway. Currently this is not an offence, so County Councils are requesting the same powers to manage pavement parking as are given to the London Boroughs. Dangerous driveways and pavements will be investigated within ten working days.

It is not widely understood that County Council cannot prevent private contractors from doing works on the highway, and they have little control over the quality of their work when making good. Highways are investigating options for putting conditions on the work and establishing a bond that can be held against satisfactory completion.

In conclusion, there are known problems with potholes, streetlights, and pedestrian properties but they are being addressed by the increase in revenue spending mentioned previously. This £9 Million will be a big help in managing the repair programme but will not address the need for capital investment. Some County Councillors recognise this and are keen to increase the investment in long term work.

# 23/23 County and District Councillors' updates District Council.

The District Council held their business awards event on 26<sup>th</sup> January. It was good to see lots of Rayleigh businesses involved at a well-received and successful event.

District Council is considering a proposal to separate the collection of green waste and food waste.

Budget will be set on 21<sup>st</sup> February.

# **County Council.**

With reference to the discussion with Cllr Scott, most of the County Council's £2 billion budget is spent on social care, the elderly and support for education. An additional £2 million is being made available for care of the elderly, £2 million more for social care and an additional £1.5 million for schools

The Council noted that the HSBC account was closed on 13<sup>th</sup> February with a final balance of £106,698 being the £106,439 originally transferred, the £226 remaining in the RTC account and the £33 interest made in the meanwhile.

# 28/23 To Consider 20's Plenty Speed limit Scheme

To consider introduction 20's plenty and safer streets programme.

The Councillors noted that Rayleigh Town Council might be too big and diverse for this programme to work over the entire parish, but it does not have to be a blanket enforcement. A suggestion that it could be put forward for estate roads, particularly those around schools was countered by the reminder that most of the schools are on main roads, so this would not help. Schools do not have parking areas and are not equipped to enforce the three parking rules of care, consideration, and caution of the 3PR scheme.

An alternative approach would be to selectively survey the parish and identify areas of concern and promote roads that would be suitable for 20mph limit. Some roads, like Grove Road are seen as rat runs that could be calmed. Residents, public transport, and utility companies would have to be consulted before any changes made. It may not be enforceable but could be made a moral obligation. It may not be respected, but will bring advantages in improved air quality, reduced damage to roads and better safety.

Noting Cllr Scott's comments about improved enforcement of speeding violations it may be more practicable to make more of enforcing the existing 30 m.p.h. limit. As there is no Highways money available, the Town Council could fund replacement or new signs if appropriate.

In conclusion, speed enforcement lies with the County Council safer streets programme and is not a matter for the town council. The Council supports 20s plenty in principle but prefer to lobby directly.
