OS67 Public forum

The meeting shall be adjourned for 15 minutes for members of the public to speak on matters relating to this agenda. A maximum of 2 minutes will be allowed per speaker.

OS68 Recommend to extend the existing contract for KGV for 1 year.

To avoid a loss of service whilst the position of the KGV Trust and Rayleigh Town Council is discussed and agreed.

Motion: to recommend to full council to extend the existing contract for KGV with Elm for 1 year.

OS69 To start an initial discussion to separate the administration of the KGV Trust from Rayleigh Town Council and to investigate the possibility of setting up a working group.

The internal auditor noted in the interim audit that the proposed council budget included expenditure the KGV playing field. As a charity this should be calculated separately. Rialtas Alpha has been purchased for the purpose of keeping the accounts separate from the Town Councils accounts and the KGV budget can be calculated via Alpha which in turn will identify the level of grant that is required from the Town Council.

OS70 To agree to sign up to SurveyMonkey for £20 per month.

SurveyMonkey will be very useful for the whole of the council. Open Spaces committee can use it to ask the publics opinions on the toilets in Rayleigh etc. The Communities Committee can use it to ask the public if they still want certain events that the Council run etc. The committee intends to use budget heading 4115 for the expenditure.

Motion: to agree to sign up to SurveyMonkey for £20 per month order that the council can gather information from the public.
